**Comments:** Parents are presented with attendance expectations at the time of enrollment. Parents are also called daily when students are absent. The family service coordinator also checks on student when needed.

**Comments:** As mentioned above daily attendance is taken and parents are called with all student absences.

**Comments:** Students are expected to attend on a regular basis and points are based upon being on time and attending school. Center Point also works closely with families who are having attendance issues.

**Comments:** Student rules are posted in the classrooms and students are acknowledged for positive behavior every 45 minutes.

**Comments:** When visiting the school, we found the students to be engaged. One instructor was using a smart board in his teaching and students were participating at a very high level. It was very interactive.

## Curriculum

What does a lesson plan look like for an average day?

Lesson plans are customized based on student needs. Center Point is teaching the CCSS in content areas and the new standards are in the course syllabus. The teacher develops the core syllabus, which includes daily lesson plans.

How are the needs assessed and met for IEP students? .

IEP student progress is assessed daily as students work toward their IEP goals. Quarterly IEP student progress is then communicated to home districts and families.

Is curriculum state approved? Yes  No

**Comments:** Center Point is using Glenco for its math and English Arts curriculum. These materials are being adapted to meet the CCSS. Science materials are teacher created. Math has also taken on more of a problem solving approach that have a real world application.

**What criteria are used for awarding grades/credits? (i.e. proficiency, mastery, project, seat-hours)**

Credits are awarded based on seat time. Center Point also expects its students to be successful with an 80% proficiency level.

**Comments:** Credits are reported for students who are progressing toward earning a diploma.

**Comments:** The teacher observed was very engaging and dynamic. Students were attentive, the instruction was engaging and other reference material was used such as showing locations on maps. It was nice to see technology in use with the smart board.
